**AGREEMENT FOR THE EXPENDITURE OF HIGHWAY MONEYS**

Agreement between the Town Superintendent of Highways for the Town of Northumberland, Saratoga County, New York and the undersigned members of the Town Board.

Pursuant to the provisions of Section 284 of the Highway Law, we agree that moneys levied and collected in the Town for the repairs and improvement of highways, and received from the State of State Aid for the repair and improvement of highways, shall be expended as follows;

1. GENERAL REPAIRS: The sum of \$490,000.00 shall be set aside to be expended for primary work and general repair upon 60.38 miles of town highways, including sluices and culverts.
2. PERMANENT IMPROVEMENT: The following Town Highways and repairs on various roads as needed.

Grangehall Rd – level and shim with 1”, widen road 12” on each side, overlay with 1 ½” 6 Top, use roller each step.

Stonebridge Rd – shim wheel ruts, overlay with 1 ½” 6 Top, use roller for each step.

Thomas Rd – overlay with 1 ½” 6 Top and roll it.

Jewell Rd – from Rte 32 to bridge – shim, add 1” of 6 Top and roll.

Louden Rd – shim with 6 Top, add 1” of 6 Top.

Work on each road will be done utilizing paver, roller and blacktop.
