Councilwoman Patricia Bryant stated that based on that information, Morning Star Excavating and Septic would be cheaper with even just one call out.

WHEREAS, the Northumberland Town Board has concerns for call outs, averaging at least one a year, on the final cost to Sewer District #1 over the life of the Agreement be it

RESOLVED, the Town of Northumberland Town Board accepts Morning Star Excavation and Septic, bid of \$226.00 per 1,000 gallons; \$452.00 per 2,000 gallon or a lump sum of \$5,424.00, and be it further

RESOLVED, that the price is good from the time of award until March 31, 2024. This price includes exposing the septic tank cover and any additional hoses needed to reach the septic tank from the driveway or road. The project is subject to prevailing wages.

- 4. Christina Kilburn, Planning and Zoning Clerk, provided information to the Town Board regarding training for the Planning and Zoning Board Members. The Capital District Regional Planning Commission (CDRPC) is offering Webinars which will take place May 4 June 3rd. The Registration Fee is \$17.50 and are good for any and all of the events in the series. It was the consensus of the Town Board Members that this is a good option. Ms. Kilburn will make Planning and Zoning Board Members aware of these Webinars.
- 5. Clean-Up Day: Councilman Paul Bolesh informed the Town Board Members that he will be holding Clean-Up week April 23 to April 30, 2022. Last year 9 town roads were cleaned of liter by residents volunteering their time. Councilman Bolesh is asking that a Newsletter be put together so residents can be made aware of this year's event.
- 6. Supervisor Willard Peck reported that there was an Emergency Situation on Grange Hall Road. A large culvert was not working properly and the water was undermining the road. Morris Excavating was hired to replace the culvert due to the emergency situation. Grange Hall Road is open again.
- 7. Supervisor Willard Peck reported that the Town's 2005 Sterling Highway Truck blew its engine and the transmission is going. Highway Supt Coffinger obtained a estimated quote from Tracey Road for the repairs and the parts and labor are \$61,614.93. Highway Supt Coffinger feels that he needs to have a spare truck. Highway Supt Coffinger stated that the Truck ordered last spring and has no estimated arrival time. It could be another year. The Town Board authorized the repairs.
- 8. John Deere 310SL Backhoe Loader: Supervisor Peck stated that Highway Supt Coffinger wanted to purchase a Backhoe Loader with his equipment fund this year. The John Deere 310 SL Backhoe Loader is on State Contract. Supervisor Peck stated that this piece of equipment would be purchased on John Deere credit which is three equal payments. Councilman Paul Bolesh made a motion authorizing the purchase of a John Deere 310SL Backhoe Loader on State Contract for the price of \$112,534.00. Councilman George Hodgson seconded the motion. All in favor, motion carried.
